RELEASE AND HOLD HARMLESS

I/We agree to hold Den-Tex Golden Triangle Dog Obedience Group (hereinafter called GTDOG) its members, directors, and officers, and the owner or lessor of the premises on N. Carroll Blvd known as the North Texas Fairgrounds (the Premises) and all agents and employees of these parties (the Released Parties), harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while on the Premises or near the entrance thereto, and I/We personally assume all responsibility and liability for any such claim.

I/We further agree to hold the Released Parties harmless from any claim for loss of this dog by disappearance, theft, death, or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage, or injury be caused or alleged to be caused by the negligence of any of the Released Parties, or by the negligence of any other person, or any other cause or causes.

I/We hereby assume the sole responsibility for, and agree to indemnify and hold the Released Parties harmless from, any and all loss and expense, including legal fees, by reason of the liability imposed by law upon any of the Released Parties for damage because of bodily injuries, including death, at any time resulting therefrom, sustained by any person or persons including myself/ourselves, or on account of damage to property arising out of or in consequence of my/our participation in this obedience class, however such injuries, death, or damage to property may have been caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the Released Parties or any other persons.

GTDOG has a zero tolerance for any aggression, whether towards another dog or a human, which occurs at any time, for whatever reason during class. If you are asked to leave the class due to dog aggression, a refund may be given if it is within the first two weeks. No refunds will be given if a dog bite occurs. I/We understand that any refund of fees will be at the discretion of the Board of Directors of GTDOG, and if granted will be on a pro-rata basis. No requests for refunds will be considered after the second week of class.
